Integrative Learning is enjoying increased attention in higher education. Organizations like the Carnegie Foundation for the Advancement of Teaching and the Association of American Colleges and Universities (AAC&U) highlight the importance of integrative thinking as an Essential Learning Outcome. Employers, too, value integrative thinking, asking higher education institutions to provide more emphasis on the application of knowledge in real world settings.

Many colleges and universities are at various stages of revising General Education and Major curricula, as well as designing specific courses and applied learning practices that encourage undergraduates to connect the various components of their learning experiences. In this workshop we will draw from the varied experiences of the participants to identify promising practices and useful next steps for encouraging integrative learning on our own campuses. Together, we will focus on three key questions: How do we define integrative learning (i.e., what are our learning goals for students)? What are the pedagogical approaches and curricular structures that facilitate integrative learning? What kinds of student learning assessment strategies offer useful formative and summative evidence of effectiveness? Informed by examples provided by the workshop facilitators and

participants, individuals will clarify and map out their own institutions' integrative learning strategies and identify next steps and promising practices to bring back to their own campuses.

For community colleges, this will mean both the "general education" they require of their own students, as well as the Associates transfer degree that will count for general-education in a four-year institution. The session will focus on particularly difficult issues such as how to establish oversight of the general-education curriculum, how to manage transfers and students entering with AP credit; how to use rubrics, how to choose software for the assessment process, how to gather classroom work and use it for action, and how to involve faculty, including adjunct faculty. Four models of gen-ed assessment will be illustrated by case studies at various types of institutions,

The past two years has seen the emergence of a new era of online learning—with elite institutions involved as never before, new online models and tools in the ascendant (e.g. MOOCs, competency, adaptive learning), and online learning positioned as a solution to major sector challenges around productivity and cost. In today's climate of unprecedented activity, media coverage and hype about online learning, all universities need an up-to-date, mission-appropriate and forward-thinking strategy, to determine what to avoid as much as what to do. This presentation will provide an overview of the past and present of online higher education in the U.S., sorting different models and approaches, and distinguishing rhetoric from reality.

The Collegiate Learning Assessment (CLA), an influential assessment administered by the nonprofit Council for Aid to Education (CAE), was designed to "measure critical thinking, problem solving, scientific and quantitative reasoning, writing, and the ability to critique and make arguments," enabling colleges and universities to comparatively "benchmark value-added growth in student learning." With the recent introduction of the CLA+, the CAE has emphasized new student-level metrics, which can be used for college admission, placement, scholarship decisions, or as an independent verification of "workreadiness skills" that graduating seniors can share with prospective employers. The CLA+ is also marketed as an instrument to independently corroborate competencybased approaches to student learning. This panel aims to engage participants in a discussion about the efficacy and appropriateness of the CLA+ as a tool for general education and writing assessment and about possible alternative approaches at the local and regional levels.

With the active support of the organization of State Higher Education Executive Officers (SHEEO) and the Association of American Colleges and Universities (AAC&U), nine states—Connecticut, Indiana, Kentucky, Forum Room

Oval Room

Massachusetts, Minnesota, Missouri, Oregon, Rhode Island and Utah—have agreed to form a Multi-State Collaborative to Advance Learning Outcomes Assessment. The states will collaborate in the development and pilot testing of a different model for learning outcomes assessment, a model that focuses on the quality of student learning and is rooted in campus/state system collaboration, in authentic student work and in faculty development and teaching activity. It is based on the use of Essential Learning Outcomes and associated VALUE Rubrics developed by faculty members under the auspices of the AAC&U LEAP initiative. The model avoids mandated standardized tests now used in many states but it will be capable of providing evidence of the quality of student learning in state systems for external stakeholders and evidence that can be used formatively by campuses for the improvement of curricular and instructional practices. Session presenters will discuss the model and pilot study plans and share perspectives from three New England states that are part of the Multi-State Collaborative.
